

Overall Status

- Optimization for IT Technology and Infrastructure
 - Complete infrastructure security assessment with the help from Delat IT infra.
- Establish Information Security Policy and Rules
 - ISO 27001 Certification on 2022/8
 - Complete ISO 27001 certification yearly review on 2023/6/8
- Protecting important Information Assets and devices
 - Ban the access of network for non-authorized equipment
 - Add MDR protection on important server




Challenge for 2023

- Attack from Outside
 - Website security flaws
 - Two middle level flaws, because they are hard to be utilized, keep watching
 - Social engineering threat and continuous APT attack to senior executives
 - Repeat phishing mail and account attack for senior executives account
- Infrastructure
 - Stability of power supply for Infrastructure
 - Protection focus on important server and establish UPS or diesel engine generator backup plan.
 - Delta Infra Integration
 - Keep improve node strength.
 - Integrate all usable resource to improve ROI of information investment
 - Internal system usage for Worldwide users
 - Move toward cloud system to reduce dependence on VPN



Information Security Policy

- Reinforce information security organization
 - The Information Security Organization was formally established in January 2020. The committee is chaired by the president and consists of toplevel executives of all units. Its main tasks include information security policy formulation, information security maintenance, information security architecture formulation, system vulnerability scanning, and product information security review.
 - The Information Security Committee appointed a head of information security and assigned dedicated staff in 2021, who meet regularly every December to review information security strategy and information security results of the year; they will also set key points of the following year's information security efforts and hand over implementation to the information security team.

Information Security Policy

- VIVOTEK Information Security Policy
 - "To protect the business information security, and to assure the business continuity"
 - The information security policy applies to all employees, contractors, vendors, and individuals interacting with VIVOTEK's information assets.
- Must Obey
 - Do not violate intellectual property rights
 - Do not install or use any software or services for business without proper authorization
 - Install antivirus software
 - Report loss of information equipment as soon as possible
 - Company e-mail is for company business use only
 - Without authorized permission, do not disclose company business information and secrets
 - Properly protect company information system account passwords
 - Promptly report any information security and network security incidents

- ISO27001 Certification Result
 - BSI reviewe audit on 2023/6
 - Base on ISO: 2013 standards 4 minor deficiencies related to
 - Firewall recovery drill
 - Node protection enhancement
 - BCP plan
 - Account review
 - No major deficiencies
 - BSI identified the effectiveness of the certification.



2023 Information Security Executive Report


- Resources
 - One security specialist in charge of writing and certifying a set of regulations or guidelines
 - Four members of an IT infrastructure team are responsible for improving the network's physical environment and software configuration
 - Education
 - Organizational information security training
 - 95.4% attending physical or online training
 - Average 1.03 hours per person



2023 Information Security Executive Report

- Execution items
 - MDR installation
 - Remove PC administrator right for normal users.
 - VPN only available with application
 - Help every PC to upgrade their OS to latest version
 - Confluence server upgrade to avoid security flaw.
 - OT network is now separated from office network.
