Introduction of the 9th term of the Board of Directors

The Board of Directors of the Company is made up of 9 directors including 3 Independent Directors with the tenure of 3 years. The election of the Board of Directors adopts the candidate nomination system stated in Article 192-1 of the Company Act. The Directors are elected from a list of candidates through the shareholders' meeting. The Board of Directors shall convene at least once quarterly, and may call a meeting at its discretion whenever necessary. The chairman of the Company leads the Board of Directors in implementing a good Board governance mechanism, improving supervision and strengthening its management function.
